EMERGENCY VIRTUAL OR REMOTE INSTRUCTION PLAN
2021 - 2022 SCHOOL YEAR
August 31, 2021

On August 11, 2021 the New Jersey Department of Education, under direction of the Governor, announced school districts shall have a plan to implement Emergency Virtual or Remote Instruction*. A day of virtual or remote instruction, if instituted under a plan approved by the Commissioner of Education, is considered the equivalent of a full day of school attendance for the purposes of meeting State and local requirements.

The Rochelle Park Board of Education authorizes, by way of Attestation, this Emergency Virtual or Remote Instruction Plan as follows:

I. Conditions for Emergency Virtual or Remote Instruction:

Emergency Virtual or Remote Instruction in the event of the district's closure lasting more than three (3) consecutive school days due to a declared state of emergency, declared public health emergency, or a directive by the state or county to institute a public health related closure.

An online schedule will be used in the event Midland School is closed due to COVID-19. A remote learning schedule is as follows:

- Period 1: 8:20am - 8:57am
- Period 2: 8:59am - 9:29am
- Period 3 9:31am - 10:01am
- Period 4 10:03am - 10:33am
- Period 5 10:35am - 11:05am
- Period 6 11:07am - 11:37am
- Period 7 11:39am - 12:09pm
- Period 8 12:11pm - 12:41pm
- Lunch 12:45pm - 1:45pm
- Extended Learning A 1:45pm - 2:15pm
- Extended Learning B 2:20pm - 2:50pm

Virtual/Remote Instructional schedules will include all subject areas as reflected on regular student and master teaching schedules.

II. Access to technology and broadband:

The district has implemented, and will continue to implement, a one-to-one technology device program. For those with identified needs, the district has provided and will continue to provide hot spots for access to internet service.

III. Safe delivery of meals:

The district has implemented and will continue to implement a schedule for pick up of pre-packaged meals. Information for pick up will be shared via email and Realtime notification message system.

IV. Minimum hours of instruction during remote learning:

If a remote, virtual learning schedule is required the bell schedule noted in Section I will be implemented. This schedule provides the minimum number of hours required to fulfill the NJ Department of Education's requirements for a school day.
