Establishing the Election of Members of the Rochelle Park Board of Education As the First Tuesday after the First Monday in November

- F8. WHEREAS, P.L. 2011, c.202 (Senate Bill 3148) authorizes a local board of education to change the election date of school board members from the third Tuesday in April to the first Tuesday after the first Monday in November (the General Election); and
 - WHEREAS, Such action requires the adoption of a resolution by a majority vote of a quorum of the local board of education; and
 - WHEREAS, P.L. 2011, c. 202 (S-3148) requires that the change in election date remain in effect for four years; and
 - WHEREAS, P.L. 2011, c. 202 (S-3148) eliminates the annual voter referendum on the proposed general fund tax levy (i.e., the base budget which is at or below the statutory tax levy cap) in school districts where board of education members are selected at the General Election; and
 - WHERAS, P.L. 2011, c. 202 (S-3148) requires that an additional general fund tax levy proposal (i.e., for an expenditure in excess of the tax levy cap) be presented to voters as a separate question at the General Election; and
 - WHEREAS, The Rochelle Park Board of Education believes that the financial interest of its constituents is safeguarded by the state's tax levy cap and the thorough review of the proposed school budget by the Executive County Superintendent and the Executive County School Business Administrator; and
 - WHEREAS, The Rochelle Park Board of Education is committed to the non-partisan status of school board membership and the non-partisan conduct of school elections, and believes this principle will not be compromised by conducting board member elections in November. Now therefore be it
 - RESOLVED, That, pursuant to P.L. 2011, c. 202 (S-3148), the Rochelle Park Board of Education changes the annual election date for its members from the third Tuesday in April to the first Tuesday after the first Monday in November (the General Election), beginning in 2012; and be it further
 - RESOLVED, That, pursuant to P.L. 2011, c. 202 (S-3148), this change will remain in effect at least through November 2015;
 - RESOLVED, That, pursuant to P.L. 2011, c. 202 (S-3148), the annual organization meeting of the Rochelle Park Board of Education will take place in the first week of

January following the November General Election and that the board of education's next organization meeting will take place in January, 2013; and be it further

- RESOLVED, That, pursuant to P.L. 2011, c. 202 (S-3148), members of the Rochelle Park Board of Education whose terms would have expired by May 1, 2012 will continue to serve in office until the January 2013 organization meeting; and be it further

Mr. Valdez- 160 Chestnut Street – inquired on the district being a focus school and what corrective measures are being put in place.

Mr. Ammerman- 5^{th} grade scores were troublesome and that put us on focus. Since then Mr. Ammerman stated he met with Mr. McGrath to discuss corrective measures. Mr. McGrath met with the teaching staff to identify students. That's who the district will be focusing on. Mr. Ammerman further stated it's a small school and 4to5 students can make a difference. Both Mr. Ammerman and Mr. McGrath are looking to see if it is a class or grade level issue. They will look at different years." If it was a problem one year, it's ok" but 3or 4 years in a row would be a problem. Its then a consistency level, that's where it could be instructional. He went on to say that they will look at the 3^{rd} and 4^{th} grades to see if it's that class and they are working with the 6^{th} graders and current 5^{th} graders with an emphasis on getting the students who were at (180-199) to 200. The staff also needs more info on Study Island; staff is very responsive to the issue.

Mrs. Rainone- President of the RPEA read a letter from the union members. She stated that the RPEA deeply cares about Rochelle Park. Mrs. Rainone, quoted from an article in the Bergen Record, where Mr. Ammerman stated that "quality of education is being delivered and that the faculty and staff has not missed a beat". The RPEA greatly appreciated this type of support. They also thanked the parents for their support during this time. Mrs. Rainone went on to state that there have been a number of administrative changes over the last few years. The teachers have been the stable factor and they are ready to meet the challenges. They respect the tax caps that the board must conform too. RPEA thought at the last session an agreement had been reached. Mrs. Rainone asked if it was something we could have worked out. RPEA wanted to know why it took so long to hear from the board. They find themselves taking a decrease. They want a fair and equitable settlement and they are committed to the children. They have pride in education and are asking for the association to be treated fairly.

Mrs. Bilka- stated Mrs. Rainone's rendition of the facts were slightly inaccurate. Mrs. Rainone – questioned the salaries on the agenda tonight, asking what percentage they represented. *Mr. Ammerman-* 2%
