VII. Reports

- A. Superintendent- Dr. DeNobile remineded everyone of the changes to the school calendar, the unsued emergency/snow days will be used on the Friday and Tuesday of Memorial day weekend May 26 &30, 2023 and the final day will be used on June 19, 2023. These dates were chosen in conjunction with the Hackensack High School schedule so families with students in both schools could be off at the same time.
- B. Business Administrator Dr. Riley explained that the boxes you see in the outer foyer are 54 hepa filter units for use in the classrooms. It was part of a state grant program. \$250,000. has been deposited in the NJ ARC account at 4.8% interest.

- C. Director of Curriculum and Instruction Mrs. Hurd announced that the state testing in Science, ELA and Math is finished, there are a few makeups. Everything is going well and will all be done by next week. Student Transition Program (STP) Summer- enrollment is up to almost 80 students. The program is in good shape. It is open to students in grades 1-8. Dr. DeNobile added that the number of parent refusals for testing has been cut in half. Investment is different due to the test prep program. The PTO raised great money through Boosterthon which will be put into various programs for our Midland students. Thank you to all the teachers/students/and of course parents for their generous donations Field trip season is underway and our students are really enjoying these experiences.
