Dr. Zoeller commented on the energy audit explaining what it was and how it works and ultimately 70% of the cost being funded by the state. With that savings the money can be used in other areas, for instance the air conditioners on the top of the gym that can only be shut off manually.

Mr. Scully asked if it was completely separate from the referendum and Library capital projects.

Dr. Zoeller explained that it is a totally different fund source.

Mr. Scully looking for clarification stated that offsets the cost.

Dr. Zoeller further explained that 30% is bonded – paid for beyond what our saved energy costs would have been. After it is paid off the money is extra.

Mr. Allos asked if the energy audit was approved.

Dr.Zoeller stated it was in January- We pay upfront, but at no cost to the taxpayer since it gets rolled into the base.
