- Thanked all involved with the 5K run and fun run held on Sept 28, 2014
- There will be a resolution on next week's agenda to approve teacher professional development workshops. Field trips for classes in PreK and Kindergarten.
- Several Policies and regulation are up for revision and approval one policy is being abolished as per our policy company Strass Esmay Associates.
- Annual approval on the Nursing Services Plan and Violence and Vandalism report will be on the agenda for approval next week as well. 1 incident reported.
- Discussion on district goals and action plans associated with those goals. They will be finalized for approval at the regular meeting.
- The district is up for NJQSAC review this year. The Board and Dr. Groveman had a discussion regarding the submission of the districts SOA. Dr. Groveman sought approval at the caucus meeting due to reporting time constraints set by the DOE.
